6 <u>Public Participation</u>

8 Play Pyramid at Lower Common

It is noted that the hand and foot holds are on the wrong way around and therefore this piece of equipment cannot be easily used in the manner it was designed. The Parish Council will looking into options to replace this with something similar.

EPC is also concerned about the traffic between residents and the traffic utilising the businesses within the industrial units currently sited there.
