#### 68 Apologies for absence

#### 71 Public Participation

<u>Eversley Cross</u> — While the road beside the play area is much improved there are still some large potholes there, will they be filled in also? EPC plans to obtain more gravel to finish filling in the potholes as best we can.

## 72 Hedges and Ditches

<u>Fallen tree in ditch</u> – The tree in the ditch that runs to Marsh Lane is still there. It is on private land but the ditch that it's in is a vital feed to the village pond. EPC will continue to communicate with the landowner to get this blockage removed.

<u>Reminder</u> – To remind all residents of their riparian obligations with regards to ditches on their land. The ditches especially round Eversley Cross are a vital feed into the village pond and without them this vital habitat for many species, including some rare ones, would be lost. EPC will write to any landowners that we are aware of that have blocked ditches requesting them to be cleared. EPC therefore would like to appeal to all residents to please keep all ditches flowing.

## 73 <u>Ditches around Marsh Lane</u>

#### **RESOLVED**

To continue to raise concerns, and escalate where possible, to obtain a satisfactory resolution to the lack of ditch maintenance here by HDC and HCC, especially as this is a known flooding hotspot.

### 74 Rubbish at the Garden Plots

The details of the quote was previously circulated to all Councillors.

#### **RESOLVED**

It was agreed to clear the rubbish left at the garden plots site at a cost of £375.00 + VAT. It was also agreed to advise the plot holders that any further rubbish left there would be split and added to their renewal invoices.

#### 75 Hedge by the ford

The details of the quote was previously circulated to all Councillors.

#### **RESOLVED**

It was agreed to cut back the hedge between the bridge and the bin beside the ford at a cost of £60.00 + VAT.

#### 76 Chequers Green footpath

The details of the quote was previously circulated to all Councillors.

#### **RESOLVED**

It was agreed to spray the whole footpath twice yearly (Spring and Summer) to try and prevent the invasive weeds from ingrowing through the surface at a cost of £75.00 + VAT.

## 77 Memorial Plaque at Chequers Green

The details of the quote was previously circulated to all Councillors.

#### **RESOLVED**

It was agreed to cut back all the Cherry trees that overhang the memorial plaque at a cost of £250.00 + VAT.

#### 78 Hedges at Chequers Green

It was agreed to cut back the hedges round the perimeter of the field at Chequers Green at a cost of £100.00 + VAT.
